A Covenant

through the Love of the almighty Father

and

through the redeeming Blood of the son Jesus Christ

which He shed at the Cross

and

through the active Fellowship empowered and united

by the Holy Spirit

and

through the eternal Word of God

the Holy Bible

Hereby we declare this covenant divinely ordained by the grace of the only omnipotent, omnipresent, omniscient and one God, revealed through the ages and the Holy Scriptures in three persons, as in the Father, the Son and the Holy Spirit. We can have fellowship because God so loved the world that he gave his only begotten son Jesus Christ to all mankind as a once and for all perfect sacrifice to redeem men from the law of sin and death. By His grace we can call on His name Jesus Christ and receive forgiveness and enlightenment to believe and preach the crucified and risen Christ.

1. The Applicant

- a. Shall be chartered as, and remain, an autonomous body. It shall be the right of self government under Jesus Christ, including the power to choose or call its pastor, elect its official board, and transact any and all business pertaining to its function as a church body .
- b. Shall have the right to use the name MISSION FOR JESUS-Country (or with approval by the Board of MFJI; MISSION FOR JESUS INTERNATIONAL) and all registered trademarks associated therewith in publications, signs, advertisements, letterheads, and other places not named herein, but that will be mutually beneficial to the local church and to Mission For Jesus , as long as it shall remain in good standing with Mission for Jesus.
- c. Shall have the right to request the assistance of the Mission For Jesus International Credentials Committee in filling a pastoral vacancy.
- d. Shall have the right to administer discipline to its members according to the Scriptures, Statutes and Bylaws of MFJI.
- e. Shall have the right to acquire and hold title to property either through authorized representatives or in its corporate name as a self-governing body.
- f. Shall have the right to operate specialized ministries of Mission For Jesus International
- g. Shall have the right to terminate the Fellowship Covenant, without cause, and agrees to notify Mission For Jesus International, by certified letter, within seven (7) days of such decision by the church governing body.
- h. Shall have the right to participate in the world missions involvement of Mission For Jesus International and to designate funds for the propagation of the Gospel of Jesus Christ.
- i. Shall have the right to representation and participation of all Mission For Jesus International camp meetings and conventions.
- j. Agrees to be faithful to the sacred trust of the ministry by diligence, by uprightness in business matters, by ministerial ethics, by self-sacrificing, by purity, by avoiding the very appearance of evil, by cherishing the anointing of the Holy Spirit, even unto death.
- k. Agrees, by the signature of its chief office, to indemnify Mission For Jesus International and its officers in any and all matters of public and private liability, including malpractice, or any other matters arising out of the actions of the applicant.
- l. Keeps the first Friday of each month as COVENANT-DAY, a sacred day of fasting, prayers and intercession for all Covenant Partners of MFJ-International around the globe.
- m. Shall support the MFJ-National Office with its Board and Director practically and financially through tithes and offerings.

2. Mission For Jesus International

- a. Shall have the right to terminate the fellowship Covenant for cause, and agrees to notify the applicant, by certified letters, within seven(7) days of such decision by the Credential Committee of Mission For Jesus International.
- b. The Credential Committee of Mission For Jesus International shall have the right to restrain the use of the Mission For Jesus/ Mission For Jesus International names and associated trademarks in any action of law and in equity in the event the applicant of any time ceases to be a cooperative fellowship.
- c. Shall, while recognizing the sovereignty of the applicant church, retain authority relative to any and all ministerial credentials issued to pastors, associate pastors, evangelists and other members of the applicant church who are credentialed by Mission for Jesus International, and such matters will be determined by the ecclesiastical process of the Mission For Jesus International Credentials Committee and not by secular law and jurisprudence.
- d. Shall have the right to recommend a person of persons to fill a pastoral vacancy, upon request from the applicant church's governing body.
- e. Agrees to be faithful to the sacred trust of the ministry by diligence, by uprightness in business matters, by ministerial ethics, by self-sacrifice, by purity, by avoiding the very appearance of evil, by cherishing the anointing of the Holy Spirit, even unto death.
- f. Agrees, By the acceptance of this application, to indemnify the applicant and its officers in any and all matters of public and private liability, including malpractice of any other matters arising out of the actions of Mission For Jesus International.
